#### 1. Approval of Previous meeting minutes: Martin C

- 2.1.General Update
  - 2.1.1. Finances
    - 2.1.1.1. We have less money than we did at this same time last year. Genessa is reconciling the books, trying to determine how we are losing money. Maybe we have not received outdoor fees from EMSA yet.
    - 2.1.1.2. We need to re-evaluate the jersey fee for next year and adjust if necessary.
