# 1. Approval of Previous meeting minutes:

1.1.June 9, 2019 – Rob asked for changes to the minutes (Cynthia was not listed in attendance; Yellowbird was to pay for a team, not a player). John made a motion to approve the previous meeting minutes with the noted changes, Rob seconded the motion, all in favour, passed.

### 2. President's Update:

2.1.General Update – MWSA is going through a lot of changes – John will expand on in section 3.

- 2.2. Unpaid Fees Policy
  - 2.2.1. One family with two players is still unpaid for Outdoor 2019. If they do not pay they will not be allowed to play in future seasons until their account is settled.
- 2.3. Missing Vulnerable Sector Check policy
  - 2.3.1. Must have a hard-line policy regarding VSCs. Team Officials without a valid VSC will not be allowed on the bench until they have submitted their VSC.
  - 2.3.2. Martin C. made a motion to create a policy requiring all members of the BSA board to have a valid Vulnerable Sector Check on file. John seconded the motion, all in favour, motion passed.
    - 2.3.2.1. Everyone must submit a VSC to Kirsten no later than July 26 or they will be removed from the board.

## 3. Past President's Update:

- 3.1. General Update MWSA changes
  - 3.1.1. MWSA is rebooting their entire program to make it more coach driven as opposed to player driven.
    - 3.1.1.1. Registrations are down every year, BSA stays static
    - 3.1.1.2. Technical program
      - 3.1.1.2.1. Technical program will be rebuilt. Looking for a new Technical Director to head the program
    - 3.1.1.3. Coaches will be taught what they need to know to coach kids at each level

- 3.1.1.4. There have been issues with referees (parents harassing, coaches harassing, referees not being trained properly)
  - 3.1.1.4.1. A "Purple Shirt" program will be implemented for referees under the age of 18 that are still learning.
- 3.1.1.5. Coaches will be required to take Respect in Sport starting Indoor 2019/20. It will be mandatory for parents at a later date.

### 4. Technical/2<sup>nd</sup> VP:

### 4.1.U5 Indoor

- 4.1.1. U5s will require appropriately sized pinnies
- 4.1.2. Don't need multicolour jerseys
- 4.1.3. John will know by mid August if Mill Woods U5 will be coming to Beaumont or not.
- 4.1.4. Draft a description of U5 program by July 31 for the website and Registration open.
- 4.2. Season End Coaches Meeting
  - 4.2.1. Look at doing a survey instead of an appreciation night or ask them at the Start Up meeting who is interested in a season wrap-up. Turnout is low.
- 4.3.EMSA U7 will be boy/girl/mixed. Beaumont will be gender specific. They might play at any soccer centre, not just South.

7.1.Need to schedule SS2020. Brielle will submit sanctioning for June 24-26, 2020 ASAP 7.2.Will include U11 for 2020 – community teams only. Fees will be the same for U11 and U13

We were short board members at Champs as Field Marshals, during the medal presentations, and for concession, to name a few.
