7. New Business

7.1 House keeping : board meeting dates, committee meetings, attendance and contribution expectations.

Importance of required attendance to 75% of board meetings in person to maintain "good standing" for player registration reimbursement, voting rights and general participation and conduct for board responsibilities. If board members continue to be absentee, the board reserves the right to remove voting rights and further act to remove board members from virtual private chats and email access. Participation in committees is expected.

7.2 U9 kick off proposal (Kathy)

Proposal of a u9 kick off on Oct 27 2024 for full day in field house as an on-boarding and introduction for players, parents and coaches to the u9 game structure. Approximately \$4000 budgeted for event, including field house rental, approx \$100 of BSA merch to sell to public, swag bags and tshirts for players. Cost to be covered or charged for event? 8-5pm scheduled timeslots with information on proper warm ups, subbing, reffing, game play, rules, scrimmaging, game sheets and management. Discussion about duplication on this event with

coaches meetings. Need to require coaches to attend the meetings. Possibility of substituting this event with 1st technical session of the fall. Maybe a shorter event or less cost will do, see how attendance goes for coaches meetings first. Revisit next meeting.

7.3 Governance committee update : volunteer commitment policy, board recognition policy (Executive)

Volunteer commitment policy changes were made by the President to change the volunteer commitment to one per youth player per season rather than over the year. Indoor to indoor and outdoor to outdoor respectively.

Board Recognition Policy change proposed to adopt one youth registration cost re-imbursement per season rather than per year.

After completing one year of satisfactory service, each Board Member in good standing is eligible to receive one free youth registration in BSA per season (Indoor and Outdoor). The youth must be the legal responsibility of the Board Member to qualify. **Youth Registrations are non-transferable**, and do not include any other miscellaneous fees that occur in team sports. *Board Members with no children of legal responsibility in BSA programs choose to forfeit this form of recognition.*

7.5 Indoor registration update (Nichole)

260 fully registered, 57 team officials, age director permissions complete via EMSA South. \$6000 in volunteer opt-out fees (\$150/player) currently approx 40 families. Aug 31 registration closes, new registrations will be permitted but \$50 late fee applies. Sept 15 2024 is the cut off date.
