### Proposed changes to BSA Bylaws – Introduced January 19, 2025

1. Article 5

Current: Annual membership fees may be established by a majority of members present and entitled to vote at a General Meeting of BSA.

2. Article 9 – Voting

Current: none

Proposed: Add 9.6 Candidates for the position of Treasurer must have served on the BSA board for the year immediately preceding the AGM in which he/she seeks the position.

## 3. Article 11 - Board of Directors

Current: 11.3 Tenure for all positions shall be for one year commencing at the annual general meeting

Proposed: 11.3 Tenure for all positions shall be for one year commencing at the annual general meeting except the positions of President, Vice President, Treasurer and Technical Director whose tenure will be for two years commencing at the annual general meeting. Odd years – Vice President and Treasurer, Even years – President and Technical Director

## 4. Article 11 – Board of Directors

Current: 11.6 Coordinators and paid Directors may be elected to the Board or appointed by the Board. Coordinators and paid Directors are not considered full members of the Board; they have a voice but no vote. Honorariums are not considered payment for positions.

Proposed: 1.6 Coordinators and paid Directors may be elected to the Board or appointed by the Board. Coordinators and paid Directors are not considered full members of the Board; they have a voice but no vote. Honorariums are not considered payment for positions.

Reason: to ensure those that are entitled to their honorariums can take it without fear of losing their vote

He/she shall present a full detailed account of receipts and disbursements to the Board whenever requested and shall prepare for submission to the Annual General Meeting a statement of the financial position of BSA and shall submit a copy of same to the Secretary for the records of BSA.
